Fuel Surcharge: - of Rs. 1750/- 20' & Rs.3200/-40' will be applicable on all Exports & Imports Containers. (The amount payable towards fuel charge may be revised without prior notice). The above mentioned all the charges are in Indian Rupees (INR) & Exclusive of Government Taxes.

Note: No Free days are applicable on Back to Town of cargo.

All rates specified in this Tariff, including handling, storage, transportation and charges for any other services, shall be applicable from the effective date of the Tariff, irrespective of the date of gate-in of the cargo/container.

Fairdeal cfs does not offer 100% free storage to any of their customers.

All invoicing will be done by Saurashtra Freight Pvt. Ltd. and all payments to be drawn in favour of "Saurashtra Freight Pvt. Ltd." (SFPL) payable at Kandla. Payments through cheque will be allowed only with prior permission of SFPL.

In case of Import delivery if the container is destuffed and the cargo / commodity is stored in our warehouse/ yard for delivery at a later time, delivery on to trucks / trailers will be affected on payment of Destuffed Cargo loading charges.

NOTE: In case of REEFER containers PTI, Plugging & Monitoring charges would be additional to the above respective handling charges.

CFS dues must be cleared prior to stuffing / seal cutting of containers. SFPL reserves the right to hold the cargo /container of any customers due to non-payment of its dues/invoices (whether disputed or not) and no claims can be made against it in this regard. Further, no CFS or other services will be provided to any customer who has not paid its dues.

Payment (through cheque/DD) shall be made at the time of Seal Cutting of Import Containers.
